There are no filing fees for any position

Missoula Elementary District #1, Hellgate Elementary District #4 & Frenchtown District #40:

- Must be a registered voter within that district
- 20 signatures are required on the nominating petition
- Affidavit of Signature Gatherer
- Oath of Candidacy
- C-1-A Forms filed (original with Commissioner of Political Practices, copy to School Clerk & Election Office)
- File forms with the school clerk

All Other Elementary Districts:

- Must be a registered voter within that district
- 5 signatures are required on the nominating petition
- Affidavit of Signature Gatherer
- Oath of Candidacy
- No financial forms for Commissioner of Political Practice are required
- File forms with the school clerk

High School District A:

- Must be a registered voter within that district
- 5 signatures are required on the nominating petition
- Affidavit of Signature Gatherer
- Oath of Candidacy
- No financial forms for Commissioner of Political Practice are required
- File forms with the school clerk

Candidates may sign their own petition.

MAY 6, 2008 SPECIAL DISTRICT ELECTIONS
FILING DECEMBER 24, 2007 THRU FEBRUARY 21, 2008

No filing fee is required

Forms Required:

- Petition for Nomination with signatures of 5 registered voters from within the district.
- Oath of Candidacy
- Affidavit for person circulating petition
- No financial forms for the Commissioner of Political Practice are required.
- File forms with the Election Office

JUNE 6, 2008 PRIMARY ELECTION
FILING JANUARY 22, 2008 THRU MARCH 20, 2008

COUNTY COMMISSIONER-DISTRICT 1

- ✓ Must reside in district for at least 2 years preceding the general election.
- ✓ Must be registered voter in Missoula County.
- ✓ File the County Partisan Office Declaration for Nomination with Election Office.
- ✓ File an original C-1-A with Commissioner of Political Practice and a copy with Election Office (form must be filed within 5 days of receiving or spending money, appointing a campaign treasurer or filing for office, whichever occurs first).
- ✓ File forms with the Election Office
- ✓ **Filing Fee is \$282.26**

CLERK OF COURT

- ✓ Must be a registered voter in Missoula County
- ✓ File the County Partisan Office Declaration for Nomination with Election Office.
- ✓ File an original C-1-A with Commissioner of Political Practice and a copy with Election Office (form must be filed within 5 days of receiving or spending money, appointing a campaign treasurer or filing for office, whichever occurs first).
- ✓ File forms with the Election Office
- ✓ **Filing Fee is \$282.26**

PRECINCT COMMITTEE PEOPLE

- ✓ File the Precinct Committeeman or Committeewoman Declaration of Nomination with us.
- ✓ No financial forms for the Commissioner of Political Practice are required
- ✓ No Filing Fee
- ✓ File forms with the Election Office
